Behavioral Agreement and Code of Conduct

This agreement is made on (date) _____ between (name of student) _____
and Meadowbank O.O.S.H and Vacation Care.

This student is entitled to enjoy the privileges of attending the recreational facility provided that he/she observes the House Rules and acts accordingly.

1. The student is expected to adhere to the rules of the OOSH/VACATION CARE AT ALL TIMES. This includes demonstrating respect for self, others, equipment and the environment.
2. The student is expected to self-regulate. All physical conflict will be treated as inappropriate and will not be tolerated.
3. All conflict resolution should be attempted verbally and with great mental deliberation. Any language, which is used to offend, insult, interrogate or abuse, is inappropriate and will not be tolerated.
4. All students will be expected to participate in activities with a nature of good sportsmanship.
5. Students will be expected to resource their own involvement in the recreational programme.
6. The coordinators of the facility will have the final decision on all student participation and if any child is deemed to be acting inappropriate, intervention will begin. Failed attempts at intervention will result in dismissal from the facility.
7. The child will take responsibility for their belongings. This includes their school uniform, lunch boxes, hats and bags. These are the responsibility of the child not the staff.
8. The student is expected to follow directions from staff for their safety and wellbeing.
9. All equipment belonging to the OOSH facility must be treated with respect. Any equipment intentionally damaged will incur a replacement fee, payable by the parent.

O.O.S.H/ Vacation Care may terminate or suspend this privilege if and when a serious breach of this Code of Behavior occurs or if there is a recurrent breach of this Code of Behavior after a warning has been given. The child will be removed from the facility immediately and re-entry will only occur when a commitment has been made to adhere to the agreement above. As this agreement holds for the duration of the student's attendance in O.O.S.H/Vacation Care, subsequent or repeated breaches will result in mediation, or in severe circumstances, removal from the facility whereby parents will need to seek alternate care.

I agree to uphold the Code of Behavior and conditions of participation outlined in the Behavioral Agreement and Code of Conduct. I agree to take responsibility for my behavior AT ALL TIMES. I understand that if this is not possible, I may no longer be able to attend.
